KACA Official Statement of Student Evaluations of Teaching

FEBRUARY 18, 2020

KACA is officially endorsing the statement issued by the American Sociological Association with the other 21 scholarly associations about the current use of student evaluations as a primary measure of teaching effectiveness of the faculty in colleges and universities in North America.

Several patterns were identified in previously published research, cited in the ASA's official statement, exhibiting that SETs systematically disadvantage women and minority faculty.

They are:

- 1. Students rate female instructors lower than male instructors even when they both exhibit the same teaching behaviors (e.g. Boring, Ottoboni, and Stark 2016; MacNell, Driscol, and Hunt 2015).
- 2. Students evaluate Black and Asian faculty members less positively than White faculty, particularly among White male students (e.g. Bavishi, Madera, and Hebl 2010; Reid 2010; Smith and Hawkins 2011).
- 3. Faculty ethnicity and gender also influence how students evaluate instructor characteristics like leniency and warmth (Anderson and Smith 2005).

KACA's official stands are following:

- 1. We strongly oppose using SETs as the primary measure of teaching effectiveness in faculty review processes, and
- 2. We strongly encourage colleges and universities in North America to consider holistic methods of evaluating one's teaching effectiveness, providing fair opportunities for women and minority teachers to advance their careers and be compensated for their achievements.

Dr. Youm's Memo to KACA

In Aug 2019, Dr. Kyu Ho Youm's wife, Bokim Youm, passed away. Many of KACA members have met Mrs. Youm in person at conferences and remember her as a strong supporter of the KACA. Mrs. Youm's unflagging support for the KACA will never be forgotten, and she will be greatly missed by all of us.

KACA: A HOME AWAY FROM HOME



"A home away from home." This expression is, perhaps, trite, but the reality is that there is a lot of truth to it in certain circumstances. For Bokim Youm, my recently deceased wife, KACA was so much more than an organization with which she was involved for many years— KACA was, in fact, a home away from home

for her. And I would be remiss in not thanking KACA for giving Bokim a sense of belonging.

On August 4, 2019, Dr. Eyun-Jung Ki (Alabama), then the KACA president, stated in her KACA email: "I am very sorry to have to share the heartbreaking news that Prof. Kyu Ho Youm's wife, Bokim Youm, passed away yesterday. Many of you have met her in person at conferences, and she was a strong supporter of the KACA."

Each time I read Dr. Ki's touching message about my unexpected loss of Bokim, I get choked up with a lot of fond memories of her KACA life, which spanned nearly 30 years.

In "Reflections on KACA's Second 'Founding' in 1990" (KACA Newsletter, July 2018), I discuss my work as KACA secretary—a discussion that would not have been complete without mentioning the pro bono work of Bokim, my young wife at that time, as an eager assistant of mine. She helped me prepare, print, and mail the KACA Newsletter, a task that was particularly challenging and time-intensive because KACA was in a transitional phase.

And through the years following, whenever she traveled with me to various conferences around the world, Bokim's priorities unfailingly centered on KACA events.

For 10 years, Bokim suffered from Parkinson's disease and related health challenges, including depression. But these issues did not deter her from joining me for KACA receptions, dinners, and private socials, such as postprandial drinks with newly promoted, tenured, or hired KACA friends. At ICA19 in Washington, D.C., in May 2019, Bokim accompanied me to the KACA dinner and cohosted the celebration of the election of Dr. Kwan Min Lee (NTU) as an ICA Fellow. If she had ever recovered and made it to

Toronto with me for AEJMC19 in August 2019, Bokim would have attended the KACA dinner and enjoyed lunch with Dr. Sun Joo (Grace) Ahn (Georgia) to congratulate her on her Krieghbaum Under-40 Award.

Clearly, Bokim's love for KACA and the people affiliated with it was reciprocal. My children (Harry, Sherry, and Eugene) and I have been overwhelmed by the outpouring of love for Bokim from numerous KACA friends. A number of exceptionally caring KACA friends went out of their way to express their heartfelt condolences. Dr. Nojin Kwak (Michigan) and Dr. David Jeong (USC) eulogized Bokim at her funeral. Dr. Joonghwa Lee (North Dakota) visited me for three days soon after the funeral. Following the Korean tradition, many others sent us condolence money, flowers, books, cards, candies, cookies, vitamins, emails, SM messages, etc.

Most striking about my KACA friends' enduring memories of Bokim was that they considered her a "mother figure" when they interacted with her in the 1990s through the 2010s.

As I continue with my existential struggle in a new life without Bokim, her KACA-related memories are all the more poignant. The most monumental kindness, though, was that KACA helped Bokim live a fulfilling life by giving her a profound sense of belonging. For this in particular, my children and I are deeply indebted to KACA.

2020 NCA Call for Papers

DEADLINE: Extended to April 8 at 11:59 pm (PST)

The National Communication Association (NCA) will hold its **106th Annual Conference in Indianapolis**, **Indiana**, **on November 19-22**, **2020.** The Korean American Communication Association (KACA) invites individual papers for competitive research sessions.

We invite submissions of papers broadly related to all areas of Korean and/or Korean-American communication themes, including but not limited to intercultural/international communication; new technologies and social media influence on communities; and contemporary communication issues in health, science, environment, sports, or entertainment. The submission of papers pursuing the convention theme, "Communication at the Crossroads" is encouraged. The KACA embraces all theoretical and methodological approaches to research.

We accept three types of submissions:

- 1. Full length completed research papers. No more than 25 double-spaced pages, excluding references, tables, and figures. Work already presented, published or accepted for presentation or publication should not be submitted. All papers must include a title and a 250-word abstract. Only full length completed papers are eligible for top research awards. Submitters should select "individual paper" as their submission type in the electronic submission form.
- **2. Extended abstracts (completed research/research in progress).** 2-3 single-spaced pages, plus references. Abstracts should clearly state: Aims, research questions, methods, projected results, and keywords (up to 6). The authors must use the individual paper submission type for their initial submission. If accepted, the authors are expected to send the full paper to the session planner no later than 6 weeks before the convention. Submitters should select "individual paper" as their submission type in the electronic submission form.

Individual papers will be blind reviewed by two or three referees/reviewers with expertise in the area. Submitters MUST DELETE ALL IDENTIFYING INFORMATION from the uploaded document before submitting a paper or abstract.

3. Panel Discussion proposal. Panel proposals should include a title, a rationale (2-3 single- spaced paragraphs), a description for the conference online program (250 words), a list of names and institutions of panelists, and summary of each paper/presentation. Panels should avoid single institution representation.

AV requests must be made at the time of submission to be considered.

Submissions open Monday, January 13, 2020 and close April 8 at 11:59 pm. Please submit your work online using the NCA Convention Central (https://ww4.aievolution.com/nca2001).

Submitters do not need to be a member of the NCA or the KACA to submit a paper/abstract/proposal for the sessions. However, if accepted, at least one author will need to (1) register for the convention and (2) attend the convention to present the work (otherwise, the presentation will be removed from the program).

All submitters are encouraged to review the **Professional Standards for Convention Participants** (https://www.natcom.org/sites/default/files/NCA_Convention_Resources_Conventi on_Standards.pdf) prior to submission. Helpful resources, including live and recorded step-by- step instructions on how to submit, are available in the **Convention Resource Library** (https://www.natcom.org/convention-events/convention-resources/convention-resource-library/scholar-scholar-faqs-and-tips).

The Korean American Communication Association (KACA) invites you to submit original research papers to the 2020 AEJMC- KACA competitive research session. Research topics that focus on various aspects of media and communication studies related to Korea are welcome. The AEJMC-KACA session embraces various theoretical orientations and methodological approaches to research.

Guidelines for All Submissions

- 1. Deadline: All submissions must be made no later than 11 p.m. EST, Thursday, April 23, 2020.
- 2. Categories of Submissions (two categories):

1) Full papers

- 25 pages maximum (no more than 25 pages), plus references, tables, figures, and all notes.
- Consistent with the APA style.

2) Extended abstracts

- 5 pages maximum, plus references, tables, figures, and all notes.
- Consistent with the APA style.
- Extended abstracts should contain a literature review, research questions/hypotheses, a detailed method section, and actual findings (NOT expected findings). Abstracts only with literature review or research questions would NOT be considered.

Full papers are preferred. Only original research will be accepted. Research studies that are already presented, submitted, or accepted for presentation or publication should not be submitted.

- 3. Submission process, requirement, and paper award
 - 1) All submissions must include a separate cover page and an abstract with approximately 250 words. A separate cover page should include the following information: paper title, author name, affiliation, mailing address, email address, and phone number.
 - 2) Author identification: Names and all information that may identify the author(s) should not appear anywhere in the paper other than on the separate cover page.
 - 3) All submissions will be blind reviewed by three reviewers with expertise in the area.
 - 4) For paper submission, authors do not need to be a member of KACA or AEJMC. However, once the paper is accepted, at least one author of the submitted paper should register for the conference, and attend the conference to present the paper at the KACA session.
 - 5) Only full papers, no extended abstracts, will be considered for the top papers. The candidates for the top student paper should have student authors only. If you have any questions regarding the call for papers, you may contact Hanna Park (Hanna.Park@mtsu.

I participated in the KSJCS-KACA joint session for the first time in my career. I was happily overwhelmed by the number of participants and attendees at the conference center to celebrate the 60th anniversary of the conference. It was interesting to learn how other scholars whose research centers around communication and Korean studies from various sub-fields of communication (journalism, mass media, and health comm) and also had an opportunity to speak with Korean professors and graduate students at the conference. The presentation was delivered in English given the nature of the joint session (also one of the presenter only speaks English) but the follow up Q&A session was held in Korean and English depending on the questions.

I think that having an internationally renowned scholar, Dr. Wayne Wanta as a presenter for the session also made it more meaningful to celebrate the role and position of scholarship of Korean mass media, journalism, and communication studies in the world. I think the joint session opened the door both for scholars in Korea and other countries to engage in intellectual conversations about our discipline.

I am sure that there will be more scholarly attention and active involvement of communication scholars in Korean studies as K-culture becomes more popular worldwide. I look forward to participating in more KACA joint sessions at other conferences.

K-Pop beyond BTS Conference

K-Pop Beyond BTS: Media Technology, Creative Industries, and Fandom Culture Yonsei University, Seoul on Dec 11, 2019

A Global Seminar on the BTS Syndrome

The Culture and Gender Studies Division of the Korean Society for Journalism and Communication Studies held a special seminar entitled "K-Pop Beyond BTS: Media Technology, Creative Industries, and Fandom Culture" at Yonsei University's Baekyang Nuri Hall in Seoul on December 11, 2019. This one-day event began with Dr. Seok-Kyeong Hong's (Seoul National University) keynote speech on the topography of Korean Wave scholarship and followed with twelve presentations about fan culture, globalization and cultural hybridity, platform, and media technology. Media and cultural studies scholars from China, Canada, the US, and the UK shared their research findings regarding the Photo Credit: KSJCS popularization of Korean pop music and celebrity culture.



K-Pop Beyond BTS

While the first session was given in English, the other three sessions were carried out in Korean. The seminar provided simultaneous translations of speeches. The venue was filled with about 200 academics, journalists, and practitioners who actively participated in heated discussions during the Q&A sessions. This event was sponsored by Big Hit Entertainment— BTS' affiliated music agency in Korea.

On that day, I presented my ongoing research regarding the technological and cultural implications of the BTS phenomenon, looking at how networking logistics have restructured and capitalized human interactions and how the power of cultural flows has placed Korean pop groups at the center of the global pop music industry. We have seen that Korean media film, pop music, online gaming, and television series—have collaboratively produced an unprecedented global sensation in the past decade. In response, several media and communication scholars have examined the alternative form of global culture and practice. Nevertheless, it still needs to be more thoroughly discussed in the context of cultural globalization. In this view, "K-Pop beyond BTS" was an insightful and inspiring academic gathering that not only enriched debate among academics but that also developed a constructive relationship between academic associations and media industries.
